SECTION 2 Terms and Conditions for High School Students

For your own safety, high school participants must abide by the following terms and conditions.

- 1. Students MUST be either a Junior (11^{th} grade) or Senior (12^{th} grade) in high school, with parental/adult verification. No exceptions.
- 2. All high school participants MUST be accompanied by an adult chaperone. The mandatory chaperone/student ratio is no more than 1:5. Groups of high school students exceeding 5 should have multiple chaperones.
- 3. If students are attending the hackathon event as a class and/or with a teacher, students must procure additional permissions proctored by their respective schools.
- 4. Students must complete a school-specific Transportation Plan upon registering for Hacks for Humanity (Page 3). If a student should need to amend their transportation plan after registering for Hacks for Humanity, student's parent/guardian should immediately contact Project Humanities at projecthumanities@asu.edu.
- 5. Students MAY NOT leave the designated premises of the hackathon (Stauffer Communications Building B) unless it is a part of their transportation plan. Going to neighboring buildings on ASU's campus constitutes going off-site and is prohibited.

SECTION 4 Waiver and Model Release Form

In consideration of the risk of injury while participating in Hacks for Humanity (the "Activity"), and as consideration for the right to participate in the activity, I hereby, for myself, my heirs, executors, administrators, assigns, or personal representatives, knowingly and voluntarily enter into this waiver and release of liability and hereby waive any and all and forever discharge Arizona State University, Stauffer B, ASU Project Humanities, their affiliates, managers, members, agents, attorneys, staff, volunteer, heirs, representatives, predecessors, successors, and assigns, for any physical or psychological injury, that I may suffer as a direct result of my participation in the aforementioned Activity, including traveling to and from an event related to this Activity.

I am voluntarily participating in the aforementioned Activity and I am participating in the Activity entirely at my own risk. I am aware of the risks associated with traveling to and from as well as participating in this Activity, which may include, but not limited to, physical or psychological injury, pain, suffering, illness, disfigurement, temporary or permanent disability (including paralysis), economic or emotional loss, and death. I agree to indemnify and hold harmless discharge Arizona State University, Stauffer B, and ASU Project Humanities against any and all claims, suits, or actions, of any kind whatsoever for liability, damages, compensation or otherwise brought by me or anyone on my behalf, including attorney's fees and any related costs, if litigation arises pursuant to any claims made by me or by anyone else acting on my behalf. If Arizona State University, Stauffer B, and ASU Project Humanities incurs any of these types of expenses, I agree to reimburse Arizona State University, Stauffer B, and ASU Project Humanities.

To the extent that statue or case law does not prohibit releases for negligence, this release is also for negligence on the par of Arizona State University, Stauffer B, ASU Project Humanities, its agents, and employees.
